**Sub: Direct Recruitment of Postal Assistant/Sorting Assistant/Postal Assistant (Circle Office) for the vacancy year 2020 on the basis of Combined Higher Secondary Level Examination, 2020 conducted by Staff Selection Commission.**

Direct Recruitment of Postal Assistant/Sorting Assistant/Postal Assistant (Circle Office) or the year 2020 was done centrally by Directorate through Staff Selection Commission. Staff Selection Commission (SSC) has recommended 3137 candidates on the basis of final result of CHSL Examination, 2020 for appointment as Postal Assistant/Sorting Assistant for the vacancy year 2020. SSC has confirmed nomination of 3136 candidates and forwarded their dossiers to the Postal Directorate. Haryana Circle had conveyed 147 vacancies in different categories i.e. PA/SA/PA (CO)/PA (SBCO) for the year 2020. The Postal Directorate has forwarded dossiers of 147 candidates allocated to Haryana Circle for appointment as Postal Assistant and Sorting Assistant for the year 2020 for being retained as part of personal file (s) of the candidate (s) concerned.

2. Postal Directorate has also forwarded the merit list of these candidates. A copy of the same is enclosed for your ready reference. As per the selection list provided by Postal Directorate, allotment of candidates to various cadres and divisions/units has been done on the basis of merit-cum-preference. As per the instructions of the Postal Directorate, following criteria has been adopted for allocation of Division/Unit to selected candidates:-

- (a) A candidate has been allocated to a Division/Unit as per merit (rank) vis a vis order of preference (option) exercised by him/her subject to availability of vacancy in a Division/Unit in the category he/she has been selected.
- (b) Person with Disability (PwD) candidates has been allocated first, irrespective of their ranks, followed by Ex-Serviceman candidates as per the available vacancies.
- (c) After the allocation of divisions/units to PwD and Ex-Serviceman candidates, remaining candidates has been allocated in the manner mentioned in (a) above.
- (d) All such candidates who did not submit any order of preference (option) has been allocated Division/Unit after allocation of all other candidates, whose preferences was received by due date, subject to availability of vacancy in a Division/Unit.

3. Names of the candidates who have been declared provisionally selected for the posts of Postal Assistant (Post Offices), Sorting Assistant (RMS) and Postal Assistant (Circle Office), the category against which they are selected and the name of the units to which they have been allocated are indicated in **Annexure-I**.

4. Dossiers of provisionally selected candidates allocated to division/unit indicated in the Annexure-I are sent herewith to initiate further action. {The Divisional Heads concerned are requested to depute ASP/IP level officer for collection of Dossiers from Circle Office Ambala. The officer so deputed may be issued a duly signed Authority letter}.

5. Divisional Heads concerned are requested to take immediate action for appointment of the selected candidates as per the following communications issued by Department of Personnel & Training (DoP&T) & Postal Directorate from time to time:

- (a) DOPT OM No. 18011/2(s)/2016-Estt. (B) (i) dated 29.06.2016, which inter alia provides that offer of appointment need not be withheld pending verification of character and antecedents.

(b) DOPT OM No. 36011/1/2012-Estt (Res.) dated 14.03.2016 which inter alia provides that where a candidate belonging to a Schedule Caste, Schedule Tribe or Other Backward Class is unable to produce a certificate from any of the prescribed authorities, he/she may be appointed provisionally on the basis of whatever prima-facie proof, he/she is able to produce in support of his/her claim, subject to his/her furnishing the prescribed certificate within a reasonable time. If there is genuine difficulty in his/her obtaining a certificate, the appointing authority should itself verify his/her claim through the District Magistrate concern.

(c) DOPT OM(s) No. (i) 1259494-Estt. (D) dated 09.08.2017 and (ii) X-07/1/2017-SPB-II dated 13.09.2017 regarding validity of offer of appointment.

(d) Directorate letter No. 60-9/2010-SPB-I dated 10.11.2010, wherein it was informed that direct recruit PA/SA may be deputed for training as soon as the slots become available in PTCs. However, keeping in view the limited slots available in PTCs, in house training may be imparted to such PA/SA by the Circles, although such training in no way shall be treated as substitute for the formal training at PTC. Till such PAs/SAs are trained in PTC, they may be detained from sensitive seats or deputed to man the counters. However, they can be utilized in back office under effective supervision.

6. Directorate letter No. 15-04/2015-SPB-I dated 30.11.2017, wherein approval of the competent authority was conveyed to discontinue the practice of execution of bonds under the provisions stipulated in Appendix 21 of Postal Manual Volume IV by direct recruit Multi Tasking Staff, Postman, Mail Guard, Postal Assistant, Sorting Assistant and Inspector of Posts at the time of joining Department of Posts.

7. It is also requested that the following documents/particulars of the candidate (s) may be checked thoroughly at the time of joining keeping in view the instructions listed in Para 5 above:-

(a) Certificate regarding Date of Birth.

(b) Certificate relating to Essential Qualification as on date prescribed in the Notice of the Examination.

(c) SC/ST/OBC/EWS/ESM/PwD Certificate, if any, issued by the competent issuing authority in the prescribed format approved by the Government of India.

(d) In respect of OBC Certificate, the guidelines regarding creamy layer status may be strictly followed.

(e) Candidates claim in respect of age relaxation, if any.

(f) Candidate's result, Rank, Category etc. may be tallied with the result available on the Staff Selection Commission's website.

(g) Photograph, signature, LTI and Handwriting specimens taken on Admission Certificate (Commission's copy) and documents at different stages of examination need to be verified with those obtained from the candidate (s) at the time of joining his/her service.

(h) Photograph of the candidate captured at the time of Computer Based Examination (all Tiers/Stages), Skill Test and Document Verification have been provided in the candidate's dossier. These photographs may be matched with each other as well as with the physically reporting candidate.

(i) The offer of appointment should be sent only by Registered Post/AD as per the address in the Dossiers directing them to attend for Original Certificates/documents for completion of their pre-appointment formalities. If the letters are returned undelivered, the letter along with the envelope containing remarks made by the Postal authorities should be retained for record. In such cases, a copy of the offer of appointment should be sent to the permanent address and email id of the candidates. The dossiers of such candidates should be returned to the concerned Regional Office of SSC only if the second letter/mail is also undelivered/unanswered.

(j) Selected candidates may also be informed that their provisional selection is subject to verification of documents like Educational Certificates, Caste, Age, Police Verification, Medical Examination etc. from competent Medical Officer and fulfilling of other terms and conditions.

(k) In cases where offer of appointment is cancelled by the Divisions/units, full facts thereof should be intimated to this office along with the dossier of the candidate concerned.

7. Directorate had further clarified vide letter No. 04-02/2017-SPB-I dated 07.02.2018 that while issuing provisional offer of appointment, the candidates may be asked to produce the originals of educational certificates and other documents such as caste certificate, ex-servicemen certificate, persons with disability certificates, certificate of date of birth etc. on the day of joining. The originals may be verified on the day of joining by the Appointing Authority that has the liberty to get the documents verified from the issuing authorities, if any of the documents appear to be suspicious. However, the appointment shall not be kept on hold on the ground that any such document appears to be suspicious.

8. The provisional offer of appointment as well as the appointment order shall clearly specify that if any information or document submitted by the candidate is found incorrect at a later stage, which would have rendered him ineligible for appearing in the Combined Higher Secondary Level Examination, 2019, he/she shall be terminated from service. In addition to this, the selected candidates may also be informed that the offer of appointment would lapse if the candidate did not join within the specified period and would lapse automatically after the expiry of six months from the date of issue of original offer of appointment.

9. On receipt of all the original certificates, the candidates may be got medically examined. Thereafter, the candidates may be appointed provisionally and posted by seeking recommendations of transfer and placement committee formed for the purpose. After completion of this appointment process, a consolidated report inter alia including names of the candidates appointed, refused to join and do not respond to offer of appointment may be sent to this office.


