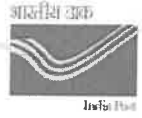

Sub: Allocation of Divisions/Units of the candidates for appointment as PA/SA based on CHSL Examination, 2020 declared by SSC.

I am directed to inform that the SSC has recommended 230 candidates on the basis of final result of CHSL, 2020. Dossiers of 230 candidates allotted to this Circle have been received from Directorate for appointment in PA/SA Cadre against the vacancies for the year 2020 (01.01.2020 to 31.12.2020). All the 230 candidates have been allocated to the Division/Unit as per the preferences received at this end and availability of vacancies. The division/unit wise allotment details are furnished in the Annexure-I.

2. Immediate action may be taken for appointment of the selected/recommended candidates as per DOPT instructions contained in OM no. 18011/2(s)/2016-Estt.)B)(i) and letter dtd. 29.06.2016 and letter no. 36011/1/2018-Estt.(Res) dtd. 14.03.2016. It is also requested that following documents/particulars of the candidate may be checked thoroughly at the time of joining.

- a) Certificate regarding Date of Birth.
- b) Certificate relating to essential qualification as on date prescribed in the notice of the Exam conducted by SSC.
- c) SC/ST/OBC/EWS/ESM/PwD certificate if any, issued by the Competent Authority in the prescribed format approved by the Govt. of India.
- d) In respect of OBC certificate, the extant guidelines regarding creamy layer status may be followed strictly.
- e) The genuineness of OBC certificate indicating Non-Creamy Layer status issued by the prescribed authorities need to be verified in case of OBC candidate who have been selected on a provisional basis.
- f) The eligibility of the candidate whose candidature has been kept provisional for reasons other than OBC status should be verified.
- g) Candidates claim in r/o age, relaxation, if any.
- h) Candidates result, rank, category etc. may be checked with the result available on the SSC's website.
- i) Photograph, signature, LTI and Handwriting taken on Admission Certificate (Commission's copy) and documents obtained at different stage of examination need to be verified with those the candidate(s) may actually submit at the time of joining in the service.
- j) Photograph of the candidate captured at the time of Computer Based Examination (all Tiers/Stages), Skill Test (if applicable) and Document Verification have been provided in the candidate's dossier. These photographs may be matched with each other as well as with the candidate who is offered the appointment.
- k) In case of any suspicion in the candidature of the candidate, the same may be referred to the Commission immediately. In case, the offer of appointment has already been issued then the case may be referred to the appropriate authorities like Central Forensic Science Laboratory (CFSL).

In addition, pre appointment formalities such as Character and Antecedent Verification & Medical Examination etc. of the candidate(s) may also be completed as per extant Rules and Regulations of the Government.

3. Copy of individual offer of appointment, when issued, may be endorsed to the concerned Regional Office of the SSC. If the letters are returned un-delivered, the letter along-with the envelope containing remark by the Postal Authorities should be retained for record. In such cases, a copy of the offer of appointment should be sent to the permanent address and email id of the candidates. The dossiers of such candidates should be returned to the concerned Regional Office of SSC only if the second letter/mail also un-delivered/un-answered respectively.

In case where offer of appointment is cancelled by the Appointing Authority, full facts thereof should be intimated to this office as well as to the Regional Office of SSC. Further, after completion of appointment process a consolidated report inter alia includes name of candidates who do not respond to offer of appointment may also be sent to Circle Office for further information to the Directorate.


In case where offer of appointment has sent to the candidate and candidate has sought extension of time of joining the post, the same may be considered with the guidelines contained in DOPT OM No. 9/23/71-Estt.(D) dtd. 06.06.1978 and OM No. 35015/2/93-Estt.(D) dtd. 09.08.1985.

4. If any candidate declines the offer of appointment or fails to report for duty, or there is no response from him/her even after reminder(s) (through Speed/Registered post with acknowledgement due), the offer of appointment should formally be cancelled and the candidate placing therein a copy each of the offer of appointment, subsequent reminder(s) and the memorandum of cancellation of the offer of appointment.

5. Offer of appointment to the candidate(s) nominated through this letter should be issued at the earliest possible so that they need not have to wait for unduly long period and also the vacancies in question are filled expeditiously. Further, in terms of DOPT OM no. 18011/2(s)/2016-Estt. (B) (i) dated 29.06.2016, issue of offer of appointment should not be withheld for want of completion of verification of character and antecedents. The appointing authorities are required to issue provisional appointment letters after obtaining attestation form and self-declaration form from the candidates. However, in case of candidates appointment to sensitive posts, guidelines issued in DOPT OM dated 29th June 2016 may be followed.


6. In case of any doubt or suspicion as regards to the eligibility or otherwise in respect of any of the recommended candidates, the Division may write to the SSC even after his/her appointment, giving details such case(s) investigated through appropriate Government Agency.

7. The Division/Unit Head should depute one responsible officer to Circle Office to collect the dossiers of the selected candidates by today positively i.e, on 22.02.2023 and receipt of the letter along-with the dossiers may please be acknowledged.
