Sub: Allocation of selected candidates of Combined Higher Secondary Level Examination (CHSLE), 2020 conducted by SSC to the Divisions/Units for their appointment as Postal Assistant/Sorting Assistant/PA (CO/RO) in Odisha Postal Circle.

The candidates as detailed in Annexure-I, who have come out successful on the basis of result of Combined Higher Secondary Level Examination-2020 conducted by Staff Selection Commission and allotted to Odisha Postal Circle by Postal Directorate vide Letter No. W-04/14/2022-SPN-I-DOP dated 30.01.2023 are further allocated to Divisions/Units as mentioned against their names.

On the basis of Postal Directorate letter No X-12/6/2021-SPN-II dated 31.12.2021, the candidates recommended by Staff Selection Commission (SSC) have been allocated to Divisions, as per merit vis a vis order of preference exercised by the candidate subject to availability of vacancy in a Division, by treating Circle as a whole even though the vacancies were calculated Division-wise. In the light of above instruction, Odisha Circle is the recruiting unit for all Postal and Sorting Assistants and as such reassessment of vacancies have been done for the Circle as a whole, keeping in view the vacancies notified earlier, rule 38 inward/outward transfer to/from Divisions approved.

Immediate action may be taken for appointment of the selected candidates as per DOPT instructions contained in OM No. 18011/2(s)/2016-Estt.(B)(i) dated 29.06.2016 and letter No. 36011/1/2012-Estt. (Res.) dated 14.03.2016.

The following documents/particulars of the candidates may be checked thoroughly.

- (a) Date of Birth.
- (b) Essential Qualification as on the crucial date.
- (c) Age relaxation claimed by the candidate (s), if any.
- (d) SC/ST/OBC/EWS/ESM/PWD certificate issued by the Competent Authority.
- (e) In respect of OBC candidate(s), the extant guidelines regarding creamy layer status may be followed strictly.

- (f) The genuineness of OBC certificate indicating non creamy layer status issued by the prescribed authorities need to be verified in case of OBC candidate (s) who have been selected on provisional basis.
- (g) The eligibility of candidate(s) whose candidature has been kept provisional for reasons other than OBC status should be verified.
- (h) Candidate's result, Rank, Category etc may be verified with the result available on the Commission's website and the list enclosed.
- (i) Photograph, signature, LTI and Handwriting taken on Admission Certificate (Commission's copy) and document obtained at different stages of examination need to be verified with those the candidate(s) may actually submit at the time of joining the service.
- (j) Photograph of the candidate captured at the time of Computer based Examination (all Tier/stages), Skill Test (if applicable) and Document verification have been provided in the candidate's dossier. These photographs may be matched with each other as well as with the candidate who is offered the appointment.
- (k) In case of any suspicion in the candidature of the candidate, the same may be referred to the Commission immediately. In case, the offer of appointment has already been issued then the case may be referred to the appropriate authorities like Central Forensic Science Laboratory (CFSL).

In addition, pre-appointment formalities such as Character and Antecedent Verification and Medical Examination etc. of the candidate(s) may also be completed as per extant Rules and Regulations of the Government.

Offer of appointment to the candidate(s) should be sent only by Registered Post and issued at the earliest possible so that they do not have to wait for unduly long period and also the vacancies in question are filled expeditiously. If the letters are returned undelivered, the letter along with the envelopes containing remarks made by the postal authorities should be retained for record. In such cases, a copy of the offer of appointment should be sent to the permanent address and e-mail id of the candidates. The dossiers of such candidates should be returned to the concerned regional office of the SSC only if the second letter/mail is also undelivered/unanswered respectively. In case where offer of appointment is cancelled by the Circle, full facts thereof should be intimated to this office as well as to the regional office of SSC. Copy of individual offer of appointment, when issued, may be enclosed to the concerned regional office of the SSC.

In case where offer of appointment has been sent to the candidate(s) and candidates(s) has sought extension of time of joining the post, the same may be considered with the guidelines contained in DOPT OM No. 9/23/71-Estt(D) dated 06.06.1978 and OM No. 35015/2/93/Estt.(D) dated 09.08.1985. Further, after completion of the appointment process a consolidated report inter alia including the names of candidates appointed, number of candidates refused to join and number of candidates who do not respond to offer of appointment may also be sent to this office for further submission to Directorate.

In case of any doubt or suspicion as regards to the eligibility or otherwise in respect of any of the recommended candidate, the Division may write to the Circle Office who in turn will inform the same to SSC even after his/her appointment, giving details for getting such cases(s) investigated through appropriate Government Agency.

Regional Office Berhampur/Sambalpur and the Divisional Heads under Hqrs Region except Bhubaneswar, Cuttack City & Puri are requested to nominate and depute one responsible officer with authorization letter and copy of ID proof for collection of dossiers of the selected candidates of their respective divisions from this office under receipt in person on or before **16:00 hrs of 23.02.2023**.

Immediately intimation be sent to the allocated candidates to attend respective D.O by Regd/AD Post and email. Also the selected candidates may be contacted over mobile phone as available in concerned dossiers. Further, verification of certificate/documents with reference to the originals available in the dossiers, collection of attestation form, good health certificate, caste certificate, oath of allegiance and other declaration as envisaged in guidelines issued from time to time will be completed at the earliest.

It may be noted that the date in "Offer of Appointment/Provisional Offer of Appointment" may be kept unfilled for the time being till further instructions from Directorate. However, on joining, formal training may be imparted and till completion of institutional training, such candidates will work only in back office.

All concerned to note and execute it accordingly.
